### MEETING OF THE BOARD OF TRUSTEES OF THE WILLIAM PATERSON UNIVERSITY OF NEW JERSEY

#### Saturday, September 20, 2008

The meeting was called to order at approximately 9:05 a.m. in the College Hall Board Room.

In accordance with the "Open Public Meetings Act," the Chairperson publicly announced and had entered into the minutes that "adequate notice" of this meeting was provided. In compliance with the Statute, this notice was posted on the University's web page and distributed to <a href="The Herald News">The Herald News</a>, <a href="The Herald News">The Record</a>, and <a href="The Star Ledger">The Star Ledger</a> more than 48 hours prior to this meeting.

It was moved and seconded to adopt the following resolution:

The resolution was unanimously adopted.

At approximately 10:40 a.m., the Public Session resumed.

#### MINUTES OF THE JUNE 28, 2008 BOARD MEETING:

The minutes of the June 28, 2008 Board meeting were approved as distributed.

Mr. Taylor welcomed everyone to the meeting and presented the report of the Committee on Trustees and Nominations affirming the newly elected officers for 2008-2009 academic year. He reported that in accordance with State regulations that the Board meet and organize annually, a new slate of officers was elected for the 2008-2009 academic year. It was moved and seconded to adopt the following resolution:

The resolution was unanimously adopted.

#### CHAIRS REPORT:

Mr. Taylor said he considered it a privilege to have served for four years as Chair of the Board. He commented that the support, cooperation, and contributions of the campus community have been invaluable. He remarked on the variety of interaction that takes place between a Board Chair and the President of the institution. He commended Dr. Speert as a role model for how that interaction should work, and praised his keen insight on the role of the President, the role of the Board and the Board Chair, and his ability to bring those insights to bear on a wide variety of issues – always helping to put things in perspective. Mr. Taylor also thanked Chief of Staff, Dr. Marc Schaeffer for his outstanding service. Having a reporting role to the Board and the President, Dr. Schaeffer exemplifies the ability to serve both and maintain the confidences of each, balancing the role perfectly and respectfully. Mr. Taylor said the Cabinet has been very supportive, and, in his opinion, represents the very best leadership team during his tenure on the Board. Mr. Taylor passed the gavel to Mr. Mazzola with a round of applause and appreciation.

Mr. Mazzola thanked Mr. Pesce and Mr. Jackson for agreeing to serve with him as Board Officers. He thanked Mr. Taylor for his long tenure of service – 18 years of active engagement. He shared some of the accomplishments made during Mr. Taylor's tenure – including the establishment of key institutional targets in the format of Dashboard Indicators. This is a unique tool for academia and representative of the forward-thinking leadership of Mr. Taylor and the Board. In the University's recent interactions with the bond financing organizations, they remarked on how impressed they were with the University's use of Dashboard Indictors to set goals and manage the institution in this way. He noted that Mr. Taylor instituted the strategic planning process and a particular tool called scenario planning. Under Mr. Taylor's guidance, the Trustees and Nominations Committee was formed, the Facilities Master Plan was updated and paved the way for the new Student Center, the groundbreaking for the new Science Building was accomplished; and his stewardship of the institution and its finances helped the University to remain stable as reflected by the positive bond ratings and external audit reports of the University, even during the period of the worst economic challenges and steadily declining state support. Lastly, Mr. Mazzola applauded Mr. Taylor for his leadership style of a shared vision, and his ability to foster consensus and a spirit of inclusion among the Board.

Mr. Mazzola spoke about the Board's strategic planning efforts through scenario planning. This model allows the Board to test potential plans against different environments or scenarios. The Board and members of the University community have invested significant time and energy on this initiative. The Board conducted a retreat on September 12 focused on enrollment management using the scenario planning format. The Board affirmed the enrollment target of 12,000. At this level, based on several financial planning models, indications are that the University can best leverage its facilities and resources and endeavor to maximize affordability for students. We are currently at about 10,500. The Board has charged President Speert and the Cabinet to work with the University community to develop plans for review by the Board in several areas including increasing application yield through marketing, branding and recruitment efforts; planning to achieve 12,000 student level by 2011 by developing enrollment and retention plans to support this goal; having enrollment reflect the ethnic diversity of the region, and particularly the anticipated growth in the Hispanic population. Geographic diversity will be sought also to enhance the students' life experience and to maximize the number of residential students. Retention is the second way to help grow our enrollment and strong attention will be given to strategies to increase retention rates. Mr. Mazzola concluded by saying that there are many interrelated components to be considered in meeting this objective.

#### PRESIDENT'S REPORT:

Dr. Speert reported that the Cabinet is already engaged in the work of meeting the enrollment target. Dr. John Martone and his division are completing a strategic enrollment management plan dealing with student recruitment, conversion and increased application yield. There is an existing Retention Committee, co-chaired by Associate Vice President Nina Jemmott and Dean Glen Sherman, charged with developing an action plan with specific deadlines to improve retention and graduation rates. Another area being pursued is providing programs at satellite locations. A task force has been formed to look at potential sites that would serve potential students from Sussex, Warren and Morris counties. Interim Dean Ana Maria Schuhmann is heading a task force of university and other key stakeholders in planning for the predicted growth in the Hispanic population in our region. President Speert will provide continuing progress reports to the Board.

The President announced the recent death of Adjunct Faculty, Stefan Grubar from the Department of Special Education. He was a long-time adjunct and a school psychologist and taught the physiology of learning disabilities. He was a great asset to our program and will be missed.

President Speert reported on the Amethyst Initiative which has been signed by 129 college presidents at the national level, with only three signing in New Jersey. This is an initiative to stimulate debate regarding lowering the national drinking age.

The President believes it is misguided. William Paterson University has instead taken a leadership role in providing positive programs to promote social norms on responsible drinking. One of our former Trustees, Sonia Rosado, through the Student Affairs Committee was a driving force for William Paterson to be proactive in educating our students about dangers associated with indiscriminate drinking. Our Alcohol.edu is a mandatory program for all freshmen. Under the leadership of Dr. Glen Sherman, William Paterson has hosted forums with our local Mayors, Police Chiefs, and local business owners to form an alliance to work together to discourage underage drinking, President Speert has participated on several national panels dealing with the education about and prevention of alcohol abuse by students.

Dr. Speert talked about Nine Strong for New Jersey – a concerted effort by the nine state colleges in New Jersey to focus attention on higher education needs in our state and gain the support of stakeholders including alumni, faculty, staff, boards, labor organizations and other supporters to reach out to legislators and the governor to help stem the outmigration of New Jersey college students, to create more residential opportunities and to empower students to graduate in a timely manner.

The President introduced the faculty promoted and awarded tenure effective September 1, 2008 and recognized each individually. They had been invited to attend the meeting and have lunch with the Board following the meeting.

#### PERSONNEL COMMITTEE:

Ms. Temple reported that the last increase for President Speert was for the FY06/07 year and not implemented until June, 2007. The Board did not make a salary increase in academic year 07/08 due to the fiscal crisis. For academic year 08/09 the Board, in carrying out their due diligence, is bringing the President's salary to the level deemed appropriate at this time. She outlined the highlights of President Speert's achievements over the last two years.

Mr. Mazzola commented that the Board's practice of transparency regarding bid waivers is followed very diligently by the Board. Ms. Temple just learned that a relative of her husband's has some involvement with Highland Associates, and in keeping with that practice and to avoid even the appearance of a conflict of interest, Ms. Temple abstained from the vote.

#### STUDENT AFFAIRS:

Mr. Jackson reported that he met with VP Martone prior to the scheduled Student Affairs Committee meeting to discuss ways to measure the satisfaction level of our students and to develop a monitoring system that would provide needed data in this area. Mr. Jackson was unable to attend the Committee meeting and asked Mr. Mazzola to pursue discussion of this topic at the meeting.

Mr. Mazzola reported on the Student Affairs Committee meeting held on August 28, 2008. The Committee's discussion stemmed from a series of questions raised by Dr. Henry Pruitt addressing the level and quality of service provided to our students. The Committee agreed it is our goal to have mechanisms in place to ensure that the students have the best possible interaction with the University faculty and staff. Dr. Martone and his staff will work on identifying goals associated with student satisfaction in each of the student services areas. The Committee will consider these and incorporate them into dashboard indicators.

Other discussion items included our alcohol education program which has received both state and national attention. The University recently received a \$750,000 grant from the State Division of Addiction Services to expand alcohol-free weekend programming, to create substance abuse recovery counseling, and to implement a substance-free residence hall. The Student Development Annual Report was distributed to the Committee. The report includes goals and accomplishments for each unit in the Division and this year each unit has added challenges for the coming year.

Mr. Jackson thanked Dr. Pruitt for his direction in focusing on and framing the discussion around student satisfaction.

It was moved and seconded to adopt the following resolution:

Mr. Mazzola reported that with the Board's agreement, he will serve as the WPU Board's representative for this organization.

The resolution was unanimously adopted.

#### **EDUCATION POLICY COMMITTEE:**

Dr. Pruitt reported that the Committee met on August 28, 2008 and reviewed a summary of curricular and program changes during academic year 2007-2008. The University received several grants including a \$200,000 federal grant for the creation of the Institute for Critical Languages, a \$2.5 million grant for Nursing from Robert Wood Johnson Foundation, and

approximately \$4 million in other grants. We received an initial five year accreditation of the Computer Science Program. There were 29 new tenure track faculty as of September 1, 2008. The Committee had an extended discussion about the Voluntary System of Accountability (VSA) and whether to submit our data at this time or defer it until a later date. The decision remains under consideration. The remainder of the discussion centered on various aspects of assessment at the University and their impact and value.

#### INSTITUTIONAL DEVELOPMENT COMMITTEE:

Mr. Mazzola reported that the Committee met on August 28, 2008 and received a final report on fundraising for FY07/08. \$4.6 million was raised during this period which represents a 26% increase from the last fiscal year. Alumni gifts increased by 56% and corporate giving went up 18%. Alumni giving is one of the dashboard indicators and it represents the level of giving but is also an indicator of alumni engagement. The University has achieved or exceeded the goals set. Mr. Mazzola also noted that the University's goals are consistent with and in some case, more aggressive than our sister institutions. He commended VP Deller and staff for their achievements. An overview of planning giving was presented. VP Deller reported that charitable trust annuities will receive major focus as part of the coming year's fundraising activities.

#### **OTHER BUSINESS:**

At approximately 12:15 p.m. there being no further business, a motion was made and seconded for the meeting to be adjourned. The motion carried unanimously.
