The minutes of the February 3, 2017 Board Meeting were approved as distributed.

CHAIR'S REPORT:

Mr. Gruel welcomed a large crowd to the Board public session. He noted the change in venue due to the anticipated larger audience along with the extended time of the meeting to 1:00 p.m. Mr. Gruel reminded those wishing to speak of the guidelines put in place to afford each speaker the consideration to be heard. He congratulated the WPU Bowling Team as the 2017 National Collegiate Club Bowling Champions. He also congratulated fellow Trustee, John Galandak, on being an honoree at the recent Legacy Gala as Distinguished Friend of the University. With Commencement a few short weeks away, Mr. Gruel stated that the Board looks forward to joining the University community at the graduate and undergraduate ceremonies taking place at Shea Center and the Prudential Center.

PRESIDENT'S REPORT:

President Waldron presented a full report reminding everyone that a busy Spring semester is coming to a close, culminating with the excitement of Commencement exercises. She reported on the large attendance at the annual Accepted Students Day and the positive signs of this recruitment cycle for the Fall 2017 freshmen class. There were several priority searches that were successfully concluded, among them the hiring of Allison Boucher-Jarvis as Vice President for Human Resources, Dr. Sandra Hill as Associate Provost for Academic Affairs, and Dr. Venkat Sharma as the Dean of the College of Science and Health. President Waldron highlighted various student accolades as well as many faculty and staff honors and awards. The February 24 Distinguished Lecturer Series featuring attorney and Brandeis University law professor Anita Hill was sold out and marks the thirty-eighth year of this successful Series at the University.

A full written report is included in the minutes of this meeting.

GOVERNMENT AND COMMUNITY AFFAIRS REPORT:

AVP DeDeo reported on the New Jersey and federal budget activity. Higher Education budget hearings are scheduled for the second week of May and, as in years past, are attended by both he and President Waldron to represent the University. Gubernatorial candidates had a deadline of April 3rd to submit their petitions to be included on the ballot for the primary to run for Governor. He noted the Republican, Democrat and Independent candidates on the ticket. Mr. DeDeo noted that William Paterson will once again be participating in the annual Wayne Day scheduled for Sunday, June 11 at the fields behind the Municipal Complex in Wayne. He also expressed his hope that William Paterson will once again be selected to partner with CBS-TV and host one of the gubernatorial debates scheduled for Fall 2017.

EDUCATIONAL POLICY AND STUDENT DEVELOPMENT COMMITTEE REPORT:

Mr. Galandak reported that the Educational Policy and Student Development Committee met on April 13, 2017. A research presentation on the framework of the Dominican Republic's economic development and opportunities for future development was given by MBA student Ramon Irizarry along with Professor Jorge Arevalo from the Cotsakos College of Business. VP Ross reported on actions in place to increase the size of the undergraduate and graduate class for Fall 2017. Provost Sandmann examined the Three-Plus-One Degree Programs which are being discussed in New Jersey and the long term implications for higher education. Provost Sandmann also updated the Committee on the full accreditation of the Nursing Program by the New Jersey State Board of Nursing. A new partnership between the School of Continuing and Professional Education and Interstudio Viaggi was discussed by Bernadette Tiernan. VP Cammarata reported on a publication of the WPU Parent/Family Bulletin which highlights topics of interest to families of current students.

FINANCE, AUDIT AND INSTITUTIONAL DEVELOPMENT COMMITTEE REPORT:

Ms. Niro reported that the Finance, Audit and Institutional Development Committee met on April 13, 2017. The Committee met privately with internal auditor, Jeff Floyd, following the committee meeting. The Committee discussed and considered comments from the Tuition Hearing that took place just prior to the meeting. Tuition and fee increases in comparison to other New Jersey colleges were presented as well as a survey of tuition, fees, room and board in Pennsylvania, Connecticut and New York. VP Bolyai presented preparations for constructing a budget for FY2018 including revenue and expenditure assumptions. Mr. Bolyai also reported on the status of renovations of Preakness Hall and that classes are scheduled for the fall 2017 semester. VP Ferguson updated the Committee on her division's progress toward goals. VP Goldstein presented an update on our marketing campaign with Fuseideas Marketing Agency which is in its fifth year.

The items before the Board at the April 28, 2017 meeting reflect personnel actions that follow the negotiated timetable for reappointments, promotions, and salary adjustments. These items are presented in item 2 on your agenda.

- Tenure-track faculty are appointed on a yearly basis. Those in their first and second year of service are reviewed in early spring for reappointment the following September. This year, 38 first and second year faculty are recommended for reappointment; one first-year faculty was not recommended for reappointment.
- Professional staff in the AFT bargaining unit are appointed on a yearly basis until they
 qualify for multi-year reappointments. 26 professional staff in their first and second year
 of service are recommended for reappointment.
- Professional staff in the AFT bargaining unit qualify for multi-year appointments after being successfully reappointed each year for five years. This year, 17 professional staff are recommended for multi-year reappointments for four or five years, depending on length of service.
- Part-time faculty and part-time professional staff are reappointed yearly based on institutional need. Twelve part-time faculty and seven part-time professional staff are recommended for reappointment.
- Tenured faculty seeking promotion go through a competitive process that includes a
 portfolio review at the department and university level, culminating with review by the
 President. This year, 14 faculty are recommended for promotion from the assistant to
 associate professor level, and 16 faculty are recommended for promotion from the
 associate to full professor level.
- Tenure-track library faculty are reappointed on a yearly basis. This year, two library faculty are recommended for reappointment.
- Aside from promotion, tenured faculty may seek a financial increase to their salary by
 engaging in a competitive process for a range adjustment. The University determines the
 number of range adjustments available on a yearly basis. Portfolios are reviewed by a
 university-wide faculty committee, the Provost, and the President. This year, three full
 professors and one associate professor are recommended for range adjustments.

 A similar salary increase and promotion process is available to professional staff in the AFT bargaining unit, based on a university-determined number and following a similar portfolio review. This year, two professional staff are recommended for performancebased promotions.
