3-18-1 RESOLUTION, APPOINTMENT OF THE PRESIDENT OF WILLIAM PATERSON UNIVERSITY

- WHEREAS The State of New Jersey Statute 18A:64-2 vests the appointment of the president, who shall be the university's chief executive officer, and set appropriate terms of employment, including compensation, in the Board of Trustees; and
- WHEREAS: The Chair of the Board of Trustees appointed a 14-member Presidential Search Committee representative of the breadth, expertise and diversity of the William Paterson University community, including members of the faculty, student body, staff, alumni, and Trustees; and
- WHEREAS: With the counsel of an executive search firm, the Presidential Search Committee undertook a national search that resulted in recommendations to the Board for candidates to be invited to on-campus interviews with various campus constituents; and
- WHEREAS: The Board elicited, reviewed and carefully considered the feedback from the Presidential Search Committee and from members of the University community; and
- WHEREAS: Dr. Richard J. Helldobler's academic and professional qualifications, experiences and accomplishments ideally fit the profile approved by the Board; and
- WHEREAS: N.J.S.A. 18A:64-6(g) authorizes the Board of Trustees to "... appoint and fix the compensation of a president of the college...," therefore, be it
- RESOLVED: That the Board of Trustees of William Paterson University appoints Richard J. Helldobler, Ph.D., to the position of President of William Paterson University, effective July 1, 2018, at the annual salary of \$330,000, with concurrent academic rank of Professor of Communication, for the period July 1, 2018 to June 30, 2021.
